- A copy of the hirers SA ID document and Proof of Residence is required. (Copies may be made at LEDZ)
- Please supply Registration No. if hiring through a registered company
- First time clients need to collect in person, goods will not be handed to a third party.
- LEDZ Hire is a COD based company. Payment and proof thereof is required prior to hire and collection of gear.
- EFT payments are welcome, and Card payments can be made at our offices.

Terms and Conditions

I/We give LEDZ permission to do an ITC and full background credit worthy evaluation check and it is also agreed that LEDZ may use any means to verify the information contained in this document. In the event of any default by the Customer of any provision of this agreement, the Customer hereby consents and authorizes LEDZ to furnish the name, credit record and repayment history of the Customer to any credit bureau as a delinquent debtor and shall be responsible for the cost and consequences thereof. LEDZ has the right to refuse hire.

As the person/s duly authorized by the company or as a sole trader (Freelancer), I/We sign this contract and hereby interpose and bind myself/ourselves as surety/ies and co-principal debtor/s, jointly and severally with the Debtor, in favour of LEDZ, for the due, faithful and punctual performance of all obligations owed by the LEDZ. I/we agree that LEDZ may proceed directly against me/us and does not have to proceed against the Debtor first and that the debt does not have to be divided between the Debtor and the surety/ies. I/we agree to pay LEDZ 2.5% interest, compounded, on all outstanding invoices issued and levied against the Debtor by LEDZ.

Equipment is available for collection the afternoon prior to the day of hire. Equipment is due back before 11h00 am on the day of return. Late returns shall be charged for as an extra day's rental if not pre-arranged. Bookings cancelled within 24hrs of collection shall not be liable for refund. Refunds due to cancellation of equipment prior to 24hrs or payment errors shall be subject to a 10% administration charge.

It is the responsibility of the Hirer to ensure that the required equipment, accessories and extras, are supplied and packed when signing for the ordered goods on collection. LEDZ will not be responsible for omitted or incorrectly packed goods. Telephonic orders may need to be confirmed via an email booking. The hirer may also on request test any or all items on collection.

This responsibility will remain with the Hirer until all signed for items are returned to LEDZ and are accepted and checked, to be in good working order.

However due to the nature of electronic and mechanical equipment as well as human error, I/We accordingly absolve and hold free of any legal liability and therefore indemnify LEDZ, its Owners, Members and Staff against death, injury, electrical shocks or disability or any claim, financial or otherwise incurred due to equipment or lighting failure, omission of equipment or any other unforeseen error whether or not due to the negligence of LEDZ, it's owners, staff and those involved.
